Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 12.08.2026.

Compliance of conditions imposed in the registration certificate.

Promoter: SVSJ Builders LLP.

Project: "NIRVANA COUNTY" Residential plotted colony on land measuring 10.6875 acres situated in the revenue estate of Village Jalalpur Khurd, Sector-22, Jind.

1. Vide letter dated 14.07.2026 and 20.07.2026, the promoter has submitted the following:

i. Compliance of Special Condition (I) imposed in the registration certificate which reads as under:

" I. The promoter shall submit the details of the 100% Master Account, 70% Escrow Account and the 30% Free Account within a period of 30 days from the issuance of this registration certificate, till which time no plots shall be sold. The Promoter is also directed to issue a public notice of size 3 x 3 (inches) (in two newspapers widely circulated in the area including one in Hindi) indicating all three accounts i.e., 100%, 70% and 30% account under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without the prior permission of the Authority."

ii. In compliance of Special Condition no. (I), the promoter has submitted copy of original newspaper (Hari Bhoomi) wherein all the three accounts (100%, 70% & 30%) related to the project have been published. The size of publication is in prescribed size i.e., 3x 3 (inches) and the contents are in order. Following are the Bank Account details published by the Promoter:

 - i. Promoter be submit copy of original newspaper (English) wherein all the three accounts related to the project have been published of size 3" x 3" inches.
 - ii. Upon searching the said website provided by the promoter, it is found that there has been a critical error on the website. It seems that the website is not in working condition as on date. Promoter needs to fix the error on the website.
4. After submission of the above, the request of the promoter will be considered.
