Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 05.08.2026.

Submission of Completion Certificate.

Promoter: M/s Ultima Realty.

Project: "Ultima Global Square" – a commercial site 2 (Pocket A) on land measuring 3.373 acres falling in residential plotted colony measuring 214.718 acres situated in Sector-33, 34 & 35, Sonipat.

Reg. No.: HRERA-PKL-SNP-340-2022 dated 31.08.2022 valid upto 05.04.2027.

1. Vide letter dated 22.07.2025, the promoter had informed that License No. 71 of 2009 dated 26.11.2009 and License No. 24 of 2014 dated 11.06.2014 were granted in favour M/s. Jindal Realty Limited and M/s. Jindal Realty Limited had sold the commercial area measuring 3.373 acres, vide conveyance deed no. 13977 dated 31.03.2022 in favour of ULTIMA REALTY.
2. Further, ULTIMA REALTY had registered the said project as a promoter. The promoter informed that M/s. Jindal Realty Limited had received a completion certificate vide Memo No. LC-2062-PA(SK)-2024/8149, dated 06.03.2024 from the office of DTCP, Haryana. They further informed that the Commercial area is also developed and completed in all manners and the customers of the said project are constructing shops on their plots. The photographs of the said Project are attached. Further, they have filed online QPR of the said project upto March 2025. Promoter requested to take on record the completion certificate of the above project.
3. Thereafter, vide this office letter dated 04.08.2025, the promoter was directed to submit the service plans of 3.373 acres commercial pocket approved by DTCP, Haryana and report whether the services laid in this area of 3.373 acres are as per the approved plans.

Promoter was also directed to submit the completion certificate for the completion of said services.

4. Now, vide letter dated 07.07.2026, the promoter has informed that commercial area is also developed and completed in all manners and the customers of the said project are constructing shops on their plots. Photographs enclosed. Online QPRs of the said project have been filed upto December 2025. They have submitted copy service plans of total township of Jindal Global City in which their commercial area measuring 3.373 acres is falling along with completion drawing of the project in which this project area is falling. In view of the afore stated submissions, the promoter requested to take on record the completion certificate of project.

5. The Authority after consideration directs the promoter to submit reply whether service plan/ estimates have been approved by the DTCP for this commercial area of 3.373 acres. – If the same have not been approved then a certification from a chartered Engineer that the services laid in this commercial area of 3.373 acres are as per norms and are operational/ functional at site.
