**Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 05.08.2026.**

**Submission of RERA Bank Account Details.**

**Promoter: Infra Private Limited.**

**Project:** "Nyraa Homes by Nysa", an Affordable Residential Plotted Colony (under DDJAY-2016) being developed on land measuring 6.7552 acres situated in the revenue estate of Village Simla Mulana, Sector 40, Panipat.

**Reg. No.:** HRERA-PKL-PNP-920-2026 dated 24.06.2026 valid upto 01.07.2030.

1. The Authority on 24.06.2026 had registered the above project alongwith the following special condition: -

i) The promoter shall submit the details of the 100% Master Account, 70% Escrow Account and the 30% Free Account within a period of 30 days from the issuance of this registration certificate, till which time no plots shall be sold. The Promoter is also directed to issue a public notice of size 3 x 3 (inches) (in two newspapers including one in Hindi widely circulated in the area) indicating all three accounts i.e., 100%, 70% and 30% account under intimation to the Authority by submitting a copy of the original publication. No RERA account shall be subsequently changed by the promoter without prior permission of the Authority.

2. Now, vide letter dated 15.07.2026, the promoter has submitted the public notice, as outlined in the certificate, duly published in two newspapers Dainik Jagran and Haryana Tribune dated 08.07.2026: -

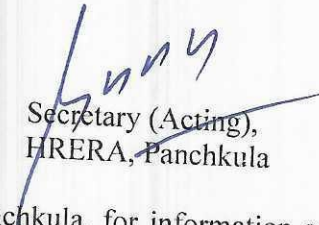
