- Since, there is revision of layout plan of the project, the promoter should submit 2/3rd consent of allottees of the project.
- Since, the date of completion of the project is 25.08.2027, Promoter should inform the development status of the project.
- Registration was granted subject to the condition that the promoter should deposit outstanding EDC/IDC within 60 days of issuance of registration certificate. Whether the same has been fully deposited to DTCP, Haryana by the Promoter.
- Promoter should mark the changes (if any) on the revised layout plan of the project.
