- 3. CA certificate on the letter head of the company has been submitted which is undated and on which UDIN of CA has not been mentioned which shows that electrical work is 50% complete, sewerage work is 95% complete, Internal Road and pavement, Water line system and storm water drainage is 90% complete. Land filling and Tin Shed, Office Construction etc. is 100% complete.
