- 1. This matter was considered by the Authority on 05.07.2023 wherein following orders were passed:-
 - 1. "M/s Ferrous Township Pvt. Ltd. vide letter dated 23.06.2023 has requested from Ferrous Township Pvt. Ltd. in which the promoter is requesting the Authority to grant permission to change the Bank account given at the time of registration. iii) Whether any sale has been effected of plots.

- 5. After submission of above information, change of bank account will be considered."
- 2. The matter was then considered by the Authority in its meeting held on 06.11.2023 but no reply was filed by the promoter and matter was adjourned to 15.01.2024 with direction to the promoter to intimate balance in the old bank account.
- 3. The matter was again considered by the Authority in its meeting held on 24.01.2024 vide item no. 239.37 wherein no reply was filed by the promoter and Authority granted an opportunity to the promoter to reply to the orders dated 05.07.2023 and 06.11.2023.
- 4. Ms. Ankita, Ld. Counsel stated that reply has been submitted on 07.03.2024.
- 5. After consideration, Authority decided that reply be examined and adjourned the matter to 01.05.2024.
