Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 01.05.2024.

## Item No. 251.20

Submission of Completion Certificate and service plan estimates.

Promoter: Galaxy Realcon Private Limited.

Project: "Galaxy Homes-2"- an Affordable residential plotted colony under

DDJAY-2016 developed over land measuring 10.687 acres (License No. 56 of 2023 dated 17.03.2023 valid upto 16.03.2028) situated in Sector-33,

Reg. No.: HRERA-PKL-RWR-478-2023 dated 19.07.2023 valid upto 31.03.2024.

- A letter was received on 03.11.2023 from the promoter submitting the Completion Certificate and service plan estimates.
- The promoter has submitted Completion Certificate dated 27.10.2023 vide Memo no. LC-4924-PA(VA)-2023/36395 w.r.t. Affordable Residential Plotted Colony (DDJAY-2016) over an area measuring 10.687 acres in revenue estate of village Bambar and Sangwari, Sector 33 Rewari, Haryana.
- The promoter has also submitted approved service plan/estimates dated 22.06.2023 vide Memo No. LC-4924/PA(VA)/2023/19945; service plan estimates; layout plan roads; layout plan domestic water supply; layout plan storm water drain; layout plan sewerage system, layout plan recycle water line.
- 4. On 21.11.2023 after consideration, Authority decided that promoter should upload up to date QPRs, and also submit environment certificate and standard designs of SCOs. Adjourned to 22.01.2024.



- 5. On 24.01.2024, Authority decided to give one more opportunity to promoter to comply with the directions of Authority dated 21.11.2023.
- 6. On 20.03.2024, the Authority adjourned the matter to 01.05.2024.
- 7. The promoter vide reply dated 19.03.2024 has stated that:
  - i. They have uploaded QPRs till 31.12.2023,
  - ii. This is a plotted colony so environment certificate is not applicable.
  - iii. Standard Designs of SCOs not approved till date, they will submit the plans as and when approved by competent authority.
- 8. After consideration, Authority decided that completion certificate be taken on record and uploaded on web portal of Authority.
