1. The Authority has registered the subject cited project on 05.10.2023. Now, vide letter dated 19.04.2024, Authorised signatory for SPJ Promoters Pvt. Ltd. has informed that till now, all the three RERA Collection Accounts were being maintained with Axis Bank at Panchkula Branch, the details of which are as under:-

 - iv. Amount of loan sanctioned by Kotak Mahindra Bank.
 - v. Is the project land mortgaged.
 - vi. Whether any loan amount has been disbursed by Kotak Mahindra Bank.
- vii. If the project land is mortgaged, now will the promoter execute conveyance deed in favour of the allottees.
- viii. Account statement of axis bank from the date of registration till date.
- ix. Account statement of Kotak Mahindra from the date of opening the said account till date.
