Change in Bank accounts of registered projects - Model Economic Township Limited.

1. The promoter vide letter dated 27.0z.2024 has submitted the bank account details opened by them for following projects with ICICI Bank for information and records of the Authority:-

- 2. The promoter has stated that since the requirement has come from RBI regulations and HDFC bank is unable to continue with earlier opened bank accounts with them to collect the amount received from allottees as well as to transfer 70% of the amount so collected in a separate account, they have no choice but to open the set of accounts with ICICI bank and assign them to different RERA registered projects. They further submitted that:-
  - They have been banking upon HDFC Bank since inception of the Company in 2006 and as such earlier opened project specific bank accounts (collection and 70% accounts) with HDFC Bank.
  - ii. In the meantime, RBI, vide circular dated 6 August 2020 has mandated that the current account shall be opened by the bank, who has credit exposure of the borrower in the banking system.
  - iii. They have not borrowed any funds from the banking system. However, they have presently non-fund -based exposure of Rs. 250 Cr from three banks namely SBI, Yes Bank and ICICI Bank.
  - iv. Since HDFC Bank could not take up any exposure with METL, they have given them the notice that all the bank accounts maintained with them will be closed/blocked on 30<sup>th</sup> March 2024. Copy of mail enclosed.
  - v. In the meantime, to protect their operations and have live/operative bank accounts to collect instalments received from allottees and also to transfer 70% of such collections in separate bank accounts for compliance under the Act, they have opened set of collection and 70% accounts with ICICI Bank and assigned these accounts to various RERA registered projects
- 3. Now, vide another letter dated 16.04.2024, they stated that the list of Bank Accounts for New accounts only has been submitted by them vide letter dated 27.03.2024 and details of old accounts were not mentioned and few corrections were needed. Now they have enclosed



a list containing details of Old and New 70% RERA accounts as a substitution to earlier submitted list:

- 4. The promoter has requested to substitute the new list and update the new bank accounts in office records.
- 5. Authority observes that promoter have opened RERA Bank Accounts in ICICI Bank without permission of Authority and thus violated the provisions of Section-4(2)(1)(d).
- 6. After consideration, Authority decided that promoter be issued show cause notice under Section-35 read with Section-61 of RERA Act, 2016 as to why penalty may not be imposed.
