Extract of the resolution passed by the Haryana Real Estate Regulatory Authority, Panchkula in its meeting held on 15.05.2024.

Item No. 253.15

Regarding continuation of registration under Section 7(3) of RERA Act for 6 projects registered with HRERA by Omaxe Ltd.

Temp ID: 442,443,445,446,447,448 of 2019.

Present: Mr. Kamaldeep Dahiya, Advocate along with Ms. Ritu.

- 1. The request of the promoter for seeking at-least one month time for submission of the information/documents for audit purpose for extension in 6 projects of Omaxe Limited was placed before the Authority in its meeting held on 26.09.2023 vide item no. 228.17 wherein the Authority decided to grant one month time from the date of application for getting the audit of the project conducted. The promoter and CA firms were informed accordingly.
- 2. Thereafter, the matter was placed before the Authority in its meeting held on 04.12.2023 vide item no. 234.09 wherein the Authority has decided that CA firms be issued reminders and promoter should be asked whether relevant information has been provided to CA firms.
- 3. Thereafter, vide letter dated 06.12.2023 Authorised signatory of Omaxe Limited has requested to grant them one month time for submission of the additional information/documents to auditors for the purpose of the above said projects.
- 4. The matter was placed before the Authority in its meeting held on 03.01.2024 vide item no. 237.10 wherein the Authority observed that the promoter is not supplying required information to Chartered Accountant firm intentionally despite grant of one month time earlier. Hence, the Authority decided that promoter should supply required information to CA firm within 10 days otherwise no extension will be granted. CA firms should intimate



Authority what information has been sought from the promoter and when the same was provided.

6. The matter was placed before the Authority in its meeting held on 21.02.2024 vide Item No. 242.13, wherein the Authority has observed that promoter is not co-operating with audit firms appointed by Authority. Audit firms be asked to intimate the Authority as to what information was sought from promoter which was provided and the information still pending. Managing Director/ one of the Directors be physically present on 10.04.2024.



- 7. Thereafter, the Authority on 10.04.2024 has informed that since Managing Director/one of the directors was ordered to be present but he did not appear. Hence, the Authority decided to impose a cost of Rs 1 Lac on the promoter. Last opportunity was granted to the promoter to be personally present on the next date of hearing. On request of Mr Rajnish, matter was adjourned to 15.05.2024.
- 8. Now, the promoter has not submitted the said penalty of Rs 1 lac. However, vide letter dated 01.05.2024, it has been informed that in registration no 138 of 2017, all necessary documents had been provided through mail on 28.11.2023
- 9. Authority decided that CA firm M/s J Mandal & Co. be changed as he is not responding. On request of Ld. Advocate, matter was adjourned to 29.05.2024.
