3. It is pertinent to mention that the date of completion of the project has been inadvertently mentioned as 30.05.2029 in registration certificate whereas it should have been 31.03.2029. So, same may be allowed to be rectified.

4. After consideration, Authority decided that Bank Account details be taken on record and uploaded on web-portal of Authority and date of completion be corrected as 31.03.2029 for which corrigendum be issued.
