Request for change of RERA Bank Account.

1. M/s Amolik Buildcon LLP vide letter dated 16.01.2023 has requested the Authority to change the bank account. The promoter has stated that, the account mentioned in REP-I Part-D (140005002768) was general account. The new details of account are as under:.

- 2. As per the orders of the Authority, following information was sought from the promoter:
  - (i) Date of opening of Account no. 140005002945, ICICI Bank;
  - (ii) Date of Rera registration of project;
  - (iii) Date on which the change of account was informed to the Authority;
  - (iv) Amount received from the allottees;
  - (v) Amount received from the allottees and deposited in Account no. 140005002944 along with CA Certificate.
  - (vi) Amount spent on the project;
  - (vii) Percentage of development works executed.



- (viii) Total amount received in Account no. 140005002945, ICICI Bank, supported by a CA certificate.
- The promoter submitted its reply on 24.04.2024 stating as under: 3.
  - (i) Date of opening of Account no. 140005002945, ICICI Bank is 10.11.2022.
  - (ii) Date of RERA registration of project is 04.11.2022.
  - (iii) Request for change of account was submitted on 19.01.2023.
  - (iv) Amount received from the allottees is ₹1,82,46,73,786/-.
  - (v) Amount received from the allottees and deposited in Account no. 140005002944 is ₹1,82,46,73,786/- as per CA certificate dated 23.04.2024.
  - (vi) Amount spent on the project till 31.12.2023 (as per CA certificate dated 23.01.2024
    - a. Spent on development works: ₹3897.75 lacs.
    - b. Total cumulative cost incurred:₹14041.79 lacs.

(vii) Percentage of development works executed: 86.62%

(viii) Total amount received in Account no. 140005002945: ₹1,28,09,19,228/-(₹1,27,72,68,428/- from 100% account and ₹36,50,800/- from promoter and other sources.)

It has been submitted that without RERA certificate, the bank had denied to open the RERA Accounts, hence they had to open new accounts after grant of RERA.

- Suo motu complaint no. 2762 of 2023 was registered against the promoter and show 4. cause notice was issued under Section 60 of the Act for violation of Section 4(2)(1)(D) of the Act for maintaining one bank account for 8 to 10 projects. Matter was listed for hearing on 03.07.2024.
- Authority observes that Promoter has replied to the observations of Authority. Hence, 5. Authority decided that new Bank account details be taken on record and uploaded on webportal of Authority.
