- Swatantra Land and Finance Private Limited vide letter dated 21.02.2024 has 1. submitted Completion Certificate of project namely "Indraprastha Greens" an Affordable Residential Plotted Colony under DDJAY on land measuring 5.775 acres situated in Sector 97, Faridabad, Haryana, registered vide registration no. HRERA-PKL-FBD-200-2020 dated 15.05.2020 valid upto 31.03.2023. Covid Extension upto 09.11.2023. First extension valid upto 09.11.2024.
- The promoter has submitted that the promoter has received completion certificate of 2 the project on 12.02.2024. Request has been made to take the same on record and grant exemption from further compliances as provided in the RERA Act, 2016.
- The promoter vide letter dated 29.03.2024 has submitted copy of service plan and 3. estimates, approved standard design plan of SCO's of commercial site, copy of demarcation



and zoning plan. The promoter has submitted that NOC for environmental clearance is not required as the project is below the prescribed limit.

- 4. The matter was last considered by the Authority on 24.04.2024 wherein it was observed as under:
 - **"**5. After consideration, Authority decided that completion certificate be taken on record and uploaded on web portal of Authority. However, promoter should file QPRs up to the date of receipt of completion certificate.
