Request for change of RERA Bank Account.

 - ii. Whether existing bank account has been closed and entire balance transferred to new bank account supported by CA certificate.
 - iii. Whether any sale has been effected of plots.
- 5. After submission of above information, change of bank account will be considered."
- 2. Authority observes that promoter has not complied with the directions issued in the meeting dated 05.07.2023. Promoter is directed to comply with the directions issued on 05.07.2023. Balance in the old bank account be also intimated.
- 3. Adjourned to 15.01.2024.
- 4. In case promoter/applicant furnishes the information before next date of hearing, their application may be considered in its Authority meeting on Monday following the date of such submission.
