- 1. The Authority had registered an affordable residential plotted colony namely "Royal Green County" vide Registration No. HRERA-PKL-JJR-414-2023 dated 24.02.2023 valid upto 31.10.2024. Now, vide letter dated 08.10.2024, the promoter has applied for further extension upto 31.10.2025.

- 5. Application for registration of project applied through "REP-V". Further, as per resolution dated 07.08.2024, the promoter is also liable to pay late fee @ 75% of extension fee.
- 6. Ld. Counsel submitted that fee/ penalty payable as per resolution of Authority dated 07.08.2024 of Rs.1,66,500/- has been deposited on 23.10.2024. After consideration, Authority decided to grant extension of one year under Section-6 of RERA Act, 2016.
