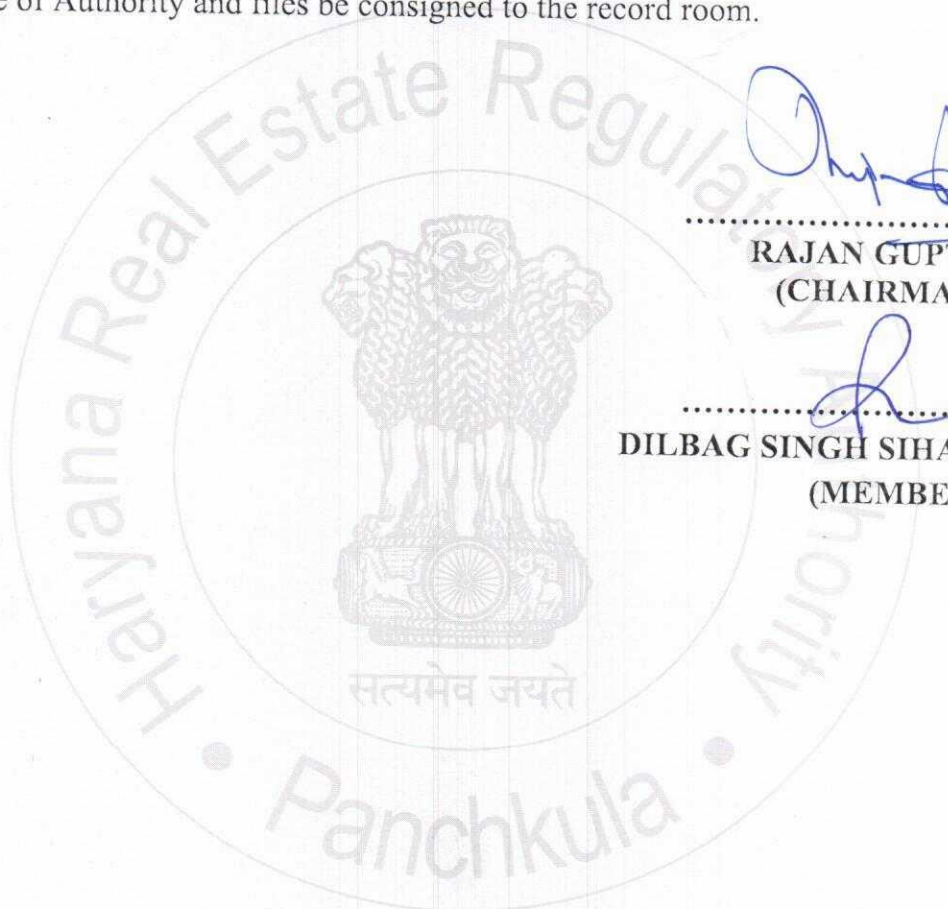
ORDER (RAJAN GUPTA- CHAIRMAN)
