Emaar India Ltd. Vs. Kranti Singh

Ld. counsel for the appellant states on the instructions of the appellant that the matter has been amicably settled between the parties vide settlement agreement dated 30.08.2021. The photocopy of the same is taken on record. She stated that she does not want to proceed further with the present appeal. The same may be dismissed as withdrawn and the amount deposited by the appellant with this Tribunal in compliance of proviso to Section 43(5) of the Real Estate (Regulation and Development) Act, 2016 may be refunded.
