This fact has not been disputed at bar that the writ petition filed by the appellant has been disposed of by the Hon'ble High Court vide Judgment/Order dated 16th October, 2020 and even the SLPs against the said judgment of the Hon'ble High Court have been disposed of by the Hon'ble Supreme Court vide Orders dated 11th May, 2022, 12th May, 2022 and 13th May, 2022. Since the appellant has not complied with the mandatory provisions of pre-deposit, so the present appeal cannot be entertained and the same is hereby dismissed.
