Proceedings

The present complaint was filed on 12.02.2020 with the adjudicating officer and the reply on behalf of respondent was received on 12.8.2021.

File has been received on transfer from Adjudicating Officer in view of the judgment dated 11.11.2021 passed by the Apex Court in the case bearing no. *SLP(Civil) No(s)*. 37113715 OF 2021) titled as *M/s Newtech Promoters* and Developers Pvt Ltd Versus State of U.P. and Ors., and wherein it was held that as matters regarding refund and interest under section 18(1) are to be decided by the authority and matters regarding adjudging compensation to be decided by the Adjudicating officer.

The instant matter pertains to the project namely "Curiocity" located at TS-02B, Sec 22D, Yamuna Expressway, Distt. Gautam Budh Nagar, U.P.
