those conditions within the specified time mentioned against each condition. Since the promoter has failed to comply with the conditions within the stipulated time, therefore, a show cause notice dated 31-10-2022 was issued to the promoter for forfeiture of bank guarantee and directed the promoter to submit the reply within 15 days failing which further order will passed by the Authority. In reference to SCN, the promoter submitted the letter dated 07-11-2022 where he submits that the delay in obtaining approvals is not on their part.

Proceedings dated: 25-11-2022

Sh. Naveen Agarwal (CS) and Sh. Charanjeet Monga (Asstt. Manager) are present on behalf of the promoter. The fire scheme approval was obtained on 26.05.2022 with a delay of 25 days. Regarding service estimates and plans, the AR submits that the matter is pending at the level of DTCP and is likely to take 3 months.

In view of the above it is clear that the condition No. 1 as mentioned in the registration certificate No. RC/REP/HARERA/GGM/529/261/20222/04, dated 31.01.2022 has not been complied with. Therefore, the BG of Rs. 10 lakhs submitted in lieu of compliance of the above condition within a period of 3 months be forfeited. The promoter/developer requests that another 3 months' time may be given to comply with the condition to submit approved service estimates and plans for which he shall submit a fresh BG for Rs. 25 lakhs within a period of 15 days. In case the same is not submitted, action under section 7(1) of the Act, 2016 shall be taken. The matter to come up on 09.12.2022.
