An application for registration of real estate project was submitted in the authority and the authority considered the application and granted registration certificate under section 5(1)(a) of the Act 2016 with the conditions mentioned above directing the promoter to comply with those conditions within the specified time mentioned against each condition. Since the promoter has failed to comply with the conditions within the prescribed time, therefore, a show cause notice dated 15-06-2022 was issued to the promoter with the direction to submit the deficit documents within 15 days failing which their real estate project registration may be revoked under 7(1) of the Real Estate (Regulation and Development) Act, 2016 and penal proceedings may be initiated under section 63 for non-compliance of the directions issued by the Authority. Also, an opportunity of hearing was offered to the promoter on 01-07-2022. In the last hearing, no one was present on behalf of the promoter, nor the promoter submitted the reply. Also, BG

None is present on behalf of the promoter.

A show cause notice was issued to the promoter on 15.06.2022. Despite service through email, speed post and uploading on web portal, no one has appeared on behalf of the promoter for the second consecutive hearing. It, therefore, shows willful noncompliance on the part of the promoter. In view of the above, a token penalty of Rs. 1,00,000/- is hereby imposed upon the promoter under section 63 of the Act, 2016 which shall be deposited within a period of 15 days from the date of this order. In case the directions of the Authority are still not complied with, it shall be open to the Authority to take further action under section 63 as well as section 7(1) of the Act, 2016. A copy of these proceedings may be supplied to the Accounts Branch. The matter to come up on 09-12-2022.

Ms. Jyoti Yadav, Planning Executive briefed about the facts of the project.

No one has appeared on behalf of the promoter despite sufficient opportunity and directions issued on the last date of hearing. In view of the above, it is clear that the promoter does not wish to state anything with regard to the show cause notice issued to him vide No.RERA-GRG-4427-2022, dated 15.06.2022 wherein it was directed to show cause why registration No. RC/REP/HARERA/GGM/370/102/2019/64, dated 07-11-2019 may not be revoked and penalty under section 63 of the RERA Act, 2016 may not be imposed. Subsequently, the promoter failed to appear on the hearing dated 01.07.2022 and thereafter another opportunity was provided on 18.11.2022 after imposition of a token penalty of Rs. 1,00,000/-.

the Authority orders the revocation of above, RC/REP/HARERA/GGM/370/102/2019/64 dated 07-11-2019 with immediate effect and further orders that the RERA accounts of the project be frozen and bank be informed accordingly. Further, a public notice be given to the above effect.
