ORDER (DILBAG SINGH SIHAG- MEMBER)

1. When the cases were called up for hearing, none appeared for the complainants. However, in the end of the cause list Sh. Saksham Arora marked his presence on behalf of complainant in complainant no. 1372/21.

2. As per last order dated 07.07.2022, cases were adjourned for filing copies of amended complaints. But complainants not appeared on hearing nor filed amended complaints till date. Authority after going through records, observes that complainants have already availed last opportunity granted by the Authority. However, complainants have failed to comply with the orders. Relevant portion of said order is reproduced below:

"Authority has gone through the documents placed on record by the complainants and finds that complaint have not been filed in proper format. Facts of the complaints are not clear nor supported by requisite documents. Documents and receipts annexed with the complaints are also in not in proper sequencing as haphazardly

attached. Authority is not able to understand the relevance of those documents as referred by the complainants. Moreover, relief prayed by the complainants are not clear as to whether they want refund of the amount deposited by them or seeking possession of the plots booked by them. In nutshell, Authority is at loss to understand the grievances of the complainants and reliefs claimed by them.

3. Hence, Authority directs the complainants to file amended complaints in proper format as per provisions prescribed under regulations of the Authority along with supporting documents to

claims.

4. Cases are adjourned to 22.09.2022 by then complainants should file thier revised complaints failing which captioned complaints will be dismissed with a liberty to file a fresh one. A copy of revised complaints be sent to the respondents to enable them to file reply".

3. Taking into consideration above observations and fact that complainants have failed to comply with above said orders till date, Authority is of the considered view that captioned complaints deserves to be dismissed. Accordingly, captioned complaints are disposed of **as dismissed** with a liberty to file fresh complaints if they desire so with better facts and reliable documents.
