ORDER: (DR. GEETA RATHEE SINGH-MEMBER)

Ms. Aishwarya Dobhal, learned counsel for decree holders stated that in compliance of previous order dated 30.11.2022, both parties visited the office of registering authority for execution of conveyance deeds in favour of decree holders mentioned in Part A of the report submitted by committee. She stated that due to technical difficulty in creating property Id by the concerned Municipal Corporation, there has been some delay caused in executing conveyance deeds. Only three conveyance deeds have been got registered, in cases where the property Id had already created on carlier occasions. Those three decree holders are namely, Sushma Sharma in execution petition no.963 of 2020, Manish Vasudeva in execution petition no.978 of 2020 and Anuradha Tyagi in execution petition no.943 of 2020. One decree holder namely, Shweta Mago in execution petition no.928 of 2020 has an appointment on Friday i.e. on 20.01.2023 for execution of conveyance deed. She further sought some time for the process of execution as the office of Municipal Corporation, Faridabad ensured that property

Id's will be generated by end of January or in first week of February 2023. She further apprised the Authority that in Part B of the committee's report, there are some execution matters in which no dues are pending against decree holders, so, she requested the Authority to give direction to the judgment debtor to execute conveyance deeds in favour of those decree holders which have no outstanding dues mentioned in Part B.

- 2. Mr. Gaurav Singla, learned counsel for the judgment debtor also reiterated that what was stated above by Ms. Aishwarya Dobhal, Advocate that the delay has been on the part of the Municipal Corporation in creating the property Id's and as soon as the property Id's are created, the judgment debtor shall get the conveyance deeds executed.
- 3. On request of learned counsel for decree holders, cases are adjourned with a direction to both parties to comply with the directions given in previous order dated 30.11.2022. Further, judgment debtor is directed to execute conveyance deeds in favour of decree holders mentioned in part B of the report against whom no outstanding dues are pending.
