Proceedings

The present complaint was disposed of vide order dated 17.08.2022 with a direction to the respondent to pay interest at the prescribed rate of 10% p.a. for every month of delay from the due date of possession (23.01.2017) till offer of possession (16.02.2022) of the booked unit after obtaining occupation certificate plus two months i.e., 16.04.2022.

The complainant has filed an application of rectification under section 39 of the Act on 12.09.2022 stating that the proceedings dated 17.08.2022 may be rectified to the extent that the amount paid by complainants is Rs. 1,98,68,920/- and the DPC should be granted upon that amount.

The authority in detail order dated 17.08.2022 has already mentioned the amount paid as Rs. 1,98,68,920/- in para 3 column 2 at page 4 of the said order.

The proxy counsel for the respondent requests for supplying of a copy of the rectification which has been supplied during the proceedings. The counsel for the complainant has attached a copy of account statement issued by the respondent confirming the receipt of an amount of Rs. 1,98,68,920/- and is also accordingly corrected and recorded in the order.
