<u>ORDER:</u>

Rajan Gupta, Chairman (Oral):

Appellant is aggrieved by para 13 (vi) of the impugned order dated 15.03.2022 passed by the Haryana Real Estate Regulatory Authority, Panchkula (hereinafter called 'the Authority'), which reads as under:

> "(vi) Respective Associations are free to deal with non-member allottees or non-paying allottees at their own level in any manner consider appropriate. However, decision in such regard should be taken in the General Body meeting of the Associations."

2. Apprehension of the appellant is that in view of the aforesaid order, more inventory may come to the notice of the respective association or the RERA Authority. According to him, this aspect needs to be clarified. He, thus, submits that he may be allowed to withdraw this appeal with liberty to move appropriate application before the Authority seeking clarification within two weeks from today. Mr. Verma, submits that he be given liberty to raise other pleas raised in the appeal before the Authority at the appropriate stage as per law. We do not deem it fit to pass any order on such prayer and this liberty is always available as per law. Needless to observe that since the RERA authority is ceased of the matter, it shall decide the same on merits.

In view of the above, the appeal is dismissed as withdrawn.
