## ORDER (DR. GEETA RATHEE SINGH - MEMBER)

- 1. On the last date of hearing dated 02.05.2023, respondent was directed to file reply. However, respondent has filed reply yesterday i.e. on 22.08.2023 in the registry. Further, he has not paid the earlier imposed cost of ₹5000/- to the Authority and ₹2000/- to the complainants till date. Copy of the reply was also not supplied to the complainants. Therefore, respondent is burdened with an additional cost of ₹5000 to the Authority and ₹2000/- to the complainants. According respondent has to pay total amount of ₹10,000 to the Authority and ₹4,000/- to the complainants within two weeks.
- 2. On perusal of file, it is revealed that present complaint has been filed by four allotees against the respondent namely HL Promoters Pvt. Ltd. Complainants in the present complaint have sought similar relief which is already under adjudication before Authority in Suo motu Complaint No. 1999 of 2022 titled as "HRERA Panchkula versus HL Promoters Pvt. Ltd. Said complaint is also against the same respondent and involves the same reliefs.
- 3. When confronted with the aforesaid factual pictorial, complainant stated that he may be allowed to withdraw the captioned complaint,

with permission, that claim of the present complainants may be
