Proceedings-cum-orders

An application under section 39 of the Act was filed by the respondent to rectify the inadvertent error in the order dated 09.12.2022, the date of OC has been inadvertently recorded as 24.12.2018 instead of 06.12.2017.

Section 39 of the Act is re-produced as under :-

"The authority may, at any time within a period of two years from the date of order made under this Act, with a view to rectifying any mistake apparent from the record, amend any order passed by it, and shall make such amendments, if the mistake is brought to its notice by the parties;

Provided that no such amendment shall be made in respect of any order against which an appeal has been preferred under this Act."

On the last date of hearing the counsel for the allottee/complainant states that an appeal has been filed against the order sought to be rectified in the Hon'ble Tribunal vide Appeal No. 299/2023.
