The present complaint has been received on 20.06.2022 and the reply on behalf of respondent no 1was received on 07.12.2022.

On 01.08.2023, the counsel for the respondent stated that the parties have already settled the matter amicably and a settlement deed dated 09.06.2023 has been placed on record on 06.07.2023. It was recorded that the matter to come up on 12.9.2023 for clarification of settlement deed as there was ambiguity in the clauses of settlement deed.

As regards the ambiguity in the settlement deed, vide order dated 12.09.2023 it was conveyed to the counsel for the respondent to clarify the adherence of the terms of settlement especially in para 2(d). The counsel for the respondent sought adjournment to file the reply for the same and the request was allowed. The counsel for the respondent was directed to file the reply within a period of one week after supplying a copy to the counsel for the complainant.

The counsel for the respondent states at bar that out of 6 instalments of the refundable amount, the one instalment have been duly paid and only 5 instalment remains to be paid which be paid within next 2 months failing
