ORDER (Parneet S Sachdev-Chairman)

Present suo-motu complaint was registered against the respondent promoter for neither completing the project within the timelines declared u/s 4(2)(l)(c) at the time of seeking registration nor applying for extension of registered project namely "HL City" a Residential Plotted Colony on land measuring 36.0975 acres in Sector -37, Bahadurgarh, Jhajjar registered vide Registration No. 77 of 2017 dated 23.08.2017 valid upto 22.08.2019.

A show cause notice dated 20.05.2022 was issued to the respondent promoter directing to furnish information relating to the status of the project on the date of expiry of registration.

- 2. When this matter was last heard on 07.08.2023, Authority had directed the respondent to file a detailed reply alongwith a table showing bifurcation of complete area measuring 36.0975 Acres.
- 3. Today, Sh. Vijender Jindal apprised the Authority that vide reply dated 09.11.2023 they have submitted the bifurcation of total area of the project and requested to drop the proceedings initiated against them. The same is reproduced as under:-
