ORDER (Anil Kumar Panwar-Adjudicating Officer)

- 1. All above titled complaint cases vide order dated 19.09.2019 were ordered to be listed before the Real Estate Regulatory Authority, Panchkula (RERA) because matters concerning refund as prayed therein, are liable to be adjudicated by RERA in view of the amendment recently carried out in HRERA Rules 2017, the relief regarding refund matters in terms of Rule 28(2)(k) has to be dealt with by Real Estate Regulatory Authority.
- 2. However, these cases have been again listed before the undersigned and the reason explained by Administrative officer (Petition) (For short AOP) is that it is technically not feasible to transfer these cases unless a new Performa-B is generated and appended with each of the complaint cases.

3. In the afore said situation, learned counsel for the complainant submits that he would generate new Performa-B in each of the complaints and would deliver its copy in the office for an enabling the Administrative officer (Petition) (AOP) to list the same before the RERA, Authority.

4. Accordingly, these cases are ordered to be listed before the Authority after attaching a revised Performa-B with each case. Necessary compliance shall be assured by the AO(P). Both the parties shall appear before RERA on 20.11.2019.
