Proceedings-cum-order

The present complaint has been received on 12.04.2022 and the reply on behalf of respondent was received on 28.04.2023.

On the last date of hearing i.e., 26.10.2023, the counsel for the respondent stated that the parent company i.e., M/s Assotech Ltd. was under provisional liquidation before the Hon'ble Delhi High Court and the respondent is a subsidiary company of the above parent company and hence, made a request for allowing zero period from 08.02.2016 to 25.03.2020.

He further stated that the unit is completed in all aspect and OC of the project is also being obtained by the respondent and assured to offer the possession of the unit at earliest. Moreover, the DPC will be adjusted while making offer of possession to the complainant/allottee and status will be filed in the registry along with written submissions within 3 weeks. The respondent has filed a written submission on 04.01.2024, in this regard which are taken on record.

However, the respondent has not placed the copy of OC on record as directed vide order dated 26.10.2023.
