<u>Rajan Gupta, Chairman (Oral):</u>

Present appeal is directed against the order dated 11.03.2024 passed by the Authority at Gurugram whereby application moved by the appellant (M/s Orris Infrastructure Pvt. Ltd.) opposing grant of RERA registration to the proposed project namely "Godrej Zenith" floated by M/s Godrej Properties Ltd. (respondent no.2 herein) in Sector 89, Gurugram, has been rejected.

2. Notice of the appeal was issued to the respondents.

3. Mr. Kunal Dawar accepted notice on behalf of respondent No.2 on the very first date of hearing.

 In view of the urgency expressed, matter was directed to be listed on the next day.

5. It has been taken up for hearing today. Learned counsel for the parties have addressed at some length. Admittedly, several contentious issues are involved. As per learned counsel for the appellant, same require urgent adjudication.

6. A query has been put to learned counsel about the jurisdictional aspect in view of the relevant provisions contained in the Real Estate (Regulation and Development) Act, 2016.

7. Learned counsel are *ad idem* that the instant matter cannot be adjudicated upon in view of the provision.

8. Under these circumstances, Mr. Gurminder Singh, Sr. Advocate submits that he has clear instructions from the appellant to withdraw this appeal as the appellant intends to approach the appropriate forum as advised.

9. In view of above, the present appeal is dismissed as withdrawn.
