ORDER


A complaint dated 22.05.2019 was filed under section 31 of the Real Estate (Regulation and Development) Act, 2016 read with rule 28 of the Haryana Real Estate (Regulation and Development) Rules, 2017 by the complainant Mr. Ravi Narain Vats, against the promoter M/s Apex Buildwell Pvt. Ltd., on account of violation of the clause 3(a) of the apartment buyer's agreement executed on 23.05.2016 in respect of apartment



number 144, 1<sup>st</sup> floor, block/tower 'Orchid' in the project 'Our Homes' for not handing over possession by the due date i.e. 02.06.2017 which is an obligation under section 11(4)(a) of the Act ibid.

- 2. Since, the apartment buyer's agreement dated 23.05.2016 was executed prior to the commencement of the Real Estate (Regulation and Development) Act, 2016, so penal proceedings cannot be initiated retrospectively. Therefore, the authority has decided to treat this complaint as an application for non-compliance of statutory obligations on the part of the respondent in terms of the provision of section 34(f) of the Act ibid.

4. The details provided above have been checked on the basis of record available in the case file which have been provided by the complainant and the respondent. An apartment buyer's agreement dated 23.05.2016 is available on record for the aforesaid apartment according to which the possession of the same was to be delivered by 02.06.2017. Neither the respondent has delivered the possession of the said unit as on date to the complainant nor has it paid any compensation as per clause 3(c)(iv) of apartment buyer's agreement dated 23.05.2016. Therefore, the promoter has not fulfilled its committed liability as on date.



5. Taking cognizance of the complaint, the authority issued notice to the respondent for filing reply and appearance. The case came up for hearing on 04.09.2019 and 11.09.2019. The reply filed on behalf of the respondent on 12.06.2019 has been perused by the authority.

#### Facts of the complaint

- 6. The complainant submitted that a complaint dated 30.04.2019 is filed under section 31 of the Real State [Regulation and Development] Act, 2016 read with rule 28 of the Haryana Real Estate [Regulation and Development] Rules, 2017 by the complainant Mr. Ravi Narain Vats, against the promoter M/s Apex Buildwell Pvt. Ltd., on account of violation of the clause 3(a) of the apartment buyer's agreement executed 0n 23.07.2016 in respect of apartment number 144, 1st floor, block/tower "Orchid" in the project "Our Homes" for not handing over possession on the due date which is an obligation of the promoter under section 11(4)(a) of the act ibid.
- 7. The complainant submitted that neither the respondent has delivered the possession of flat on 02.06.2017 to the purchaser nor had it paid any compensation at the rate of Rs. 10 /- per sq. Ft. Per month of the carpet area of the said flat for the period of delay as per clause 3(c) (IV) of the said agreement duly




executed between the parties. Therefore, the promoter has not fulfilled his committed liability as on date.

- 8. The complainant submitted that respondent is developing project namely "Our Homes" situated at sector 37-C, Gurugram therefore the Honourable authority has the jurisdiction to try the present complaint. Relying on the advertisements, the complainant had applied in an affordable housing project under government of Haryana affordable housing scheme and was allotted the said apartment having a carpet area of 48 square metres approximately with an exclusive right to use the apartment together with proportionate unidentified, impartial interest in the land underneath with right to use the common areas and facilities in the said housing complex vide apartment buyer's agreement.
- 9. The complainant submitted that the apartment buyer's agreement was executed on 23.07.2016 wherein the respondent has promised to handover possession of the unit within 36 months plus 6 months grace period from the commencement of construction upon the receipt of all approvals and the respondent failed to develop so called project within the said period. However, till date the possession of the said unit has not been handed over to the



complainant. The basic sale price was Rs. 16,00,000/- and the complainant made payments of all the instalments demanded by the respondent amounting to Rs.13,60,237/-.

- 10. The complainant submitted that on visiting the site complainant found that construction of the project is poor quality.
- occasions requested the respondent telephonically as well as through personal visits at their office and also for delivering possession of the apartment and met with officials of the respondent in this regard and completed all the requisite formalities as required by the respondent but despite that the officials of the respondent's company did not have any satisfactory reply to the complainant and lingered on one pretext or the other and refused to deliver the possession of the above set unit.
- 12. The complainant submitted that respondent is providing false and fabricated advertisement, therefore concealed true and material facts about the status of the project and mandatory regulatory compliances and thus wrongfully induced the complainant deposit his hard earned money in their so-called upcoming project, with sole dishonest intention to cheat and





cause wrongful loss to them and in this process the respondent gained wrongfully, which is purely a criminal act.

- 13. The complainant submitted that on checking the construction quality internal wall plaster of his allotted unit, sand came to his hand and it seemed as if the sand was not mix with right proportion of cement. The complainant requested that some concerned authority which issued license to the builder be held accountable and there should be adopted some mechanism in order to check the basic construction quality as otherwise there will be risk to life more than 1100 families who will start living there it is thus requested to check the basic construction quality of the structure built till now and for further remaining important work life electrification, lifts, fire safety etc. That is still pending as respondent might try to use/deeply cheapest and lowest category material in absence of any such checks from Civic authority.
- 14. The complainant tried his level best to reach the representatives of respondent to seek a satisfactory reply in respect of said dwelling unit but all in vain. The complainant had also informed the respondent about his financial hardship of pay monthly rent due to delay in getting possession of the said unit. The complainant had requested the respondent to deliver possession of the apartment citing the extreme



financial and mental pressure he was going through but the respondent never cared to listen to his grievances and left with more suffering and pain on account of default and negligence.

- 15. The complainant submitted that some buyers of the project in question have filed complaint about this delay in CM window and one of the complainants has been forwarded to DTP office, Sector 14, Gurugram on the request of home buyers, Mr R S Batt visited the site along with ATP Mr. Manish on 15 January 2018 and at that point the complainant came to know that the DTCP licence has been expired and not renewed. Thereafter many buyers requested to Mr. Batt to take some action and help them to get this project complete as early as possible. This is respondent's responsibility to chase for licence renewal before a sufficient time of expiry and moreover chase with regular follow up till it is renewed.
- 16. The complainant submitted that it seems that the funds collected from this project from buyers have been moved outside in other assets for their own interest. Even the new office building of respondent at Sector 32, Gurgram has been commenced in the year of 2014.
- 17. The complainant submitted that inspite of several requests on telephone to office, E-mails, letters by speed post respondent has not provided original acknowledgements of cheques



received and application form. Only duplicate receipts were provided when complainant went to office on 26.04.2019.

## Issues raised by the complainants:

- 18. The following issues are raised by the complainant:
  - i. Whether the respondent has violated the terms and conditions of the apartment buyer's agreement dated 23.05.2016?
  - ii. Whether the petitioner/complainant is entitled for possession of the flat?

#### 19. Relief sought:

The complainant is seeking the following relief:

- a) The respondent is directed to pay same interest 18% per annum which charged from consumer as per rolling interest @ 18% per annum.
- b) Direct the respondent to offer immediate possession of the sad flat.

### Respondent's reply

20. The respondent submitted that the complainant does not have any real cause of action to pursue the present complaint and



the complainant has filed the present complaint only to harass the respondent builder and gain wrongfully.

- 21. The respondent submitted that the reliefs prayed for the in the case pertains only for adjudication of the compensation, therefore, this hon'ble authority lacks jurisdiction in the present matter and only the adjudicating officer appointed under section 71 of the said Act is empowered for the same and hence the present complaint filed under rule 28 being non maintainable is liable to be rejected/dismissed right-away.
- 22. The respondent submitted that the complainant is estopped to file the present complaint due to her own acts and conduct. The plan chosen and terms agreed between the parties are very much binding on the applicant. The failure to pay the due amounts in a timely manner by so many of the allottees including the complainant have led to multiple problems and extra costs on the respondent leading to further delays.
- 23. The respondent submitted that it is very well committed to the development of the real estate project and the delay being occasioned for delivering the possession of the project is only because of explainable and extendable as per clause 3(b)(i) and (ii) of the apartment buyer's agreement and is due to



- causes beyond the control of the respondent, therefore the complainant is estopped from filing the present complaint.
- 24. The respondent submitted that firstly, on grant of license bearing no. 13 of 2012 dated 22.02.2012, the respondent applied for all other relevant permissions and could secure the BRIII for sanction of building plans only on 7.05.2013 and the consent to establish by the office of HSPCB, Panchkula was only granted on 2.12.2013. Since then the respondent is continuing the construction of the project, but to the misery the license so granted expired on 21.02.2016 i.e. prior to the permissible period of construction of 36 months and since 11.02.2016, the respondent is seeking the renewal of the license from the Office of DGTCP, Haryana and finally the same has now been received on 26.04.2019 and the respondent is duty bound to deliver the possession of the project within the permissible time.
- Estate (Regulation and Development) Act, 2016 came into force on 28.07.2017 for which the respondent duly filed an application dated 28.08.2017 and due to lapse of license no. 13 of 2012, the same got dismissed vide orders dated 19.01.2018 leading to further operational obstacles and restrictions of funds in completion of the project.



- 26. The respondent submitted that since then the respondent is hard trying to avail all the approvals, permissions and sanctions from the relevant authorities. The approvals and license be granted in time the respondent, given the speed and efficiency of construction would have duly completed the project within the permissible time period. The respondent submitted that it is the respondent who is suffering due to the delay that is being occasioned and has to face extra charges and costs and expenses in getting all the above permissions renewed.
- 27. The respondent submitted that as per clause 3 of the apartment buyer's agreement executed with the complainant, it was agreed between the parties that the respondent shall hand over the possession of the apartment within 36 months with a grace period of six months from the date of commencement of construction of the complex upon the receipt of all project related approvals including sanction of building plan/revised building plan and approval of all concerned authorities including the fire service department, similar vision department, traffic department, pollution control department etc., as may be required for commencing carrying on and completing the said complex subject to force majuere, restraints of restrictions from any code/authorities.



Further as per clause 3(b) of the agreement, it was agreed between the parties that the date of the possession shall get extended in the following situation:

- The completion of the said low-cost/affordable group i. housing project including the apartment is delayed by reason of non-availability of steel and/or cement or other building materials, or water supply or electric power or slow down, strike or, lock out or civil commotion or by reason of war or enemy action or terrorist action or earthquake or any act of god or due to circumstances beyond the power and control of the developer or due to any act, notice, order, rule or modification of the government and/or any other public or competent authority or due to delaying sanction of any revised building/zoning plans/grant of occupation certificate or for any other reason beyond the control of the developer, then the apartment allottees agrees that the developer shall be entitled to extension of time for offering the possession of the said apartment.
- ii. If as a result of any law that may be passed by any legislature or rule, or regulation or order on notification that may be made and/or issued by the government or any other authority including a minuscule authority or on



account of delay in sanctioning of plans or any other sanction or approval for development or issuance of occupation certificate by appropriate authorities, the developer is not in a position to hand over the possession of the apartment then the developer may, if so advised though not bound to do so at its sole discretion challenge the validity, applicability and/or efficacy of such legislation, rule, order or notification by moving the appropriate courts, tribunals and/or authorities.

- 28. The respondent submitted that the complete real estate industry is under pressure of delivery and the availability of skilled manpower and material is at its all-time low and thereby, the respondent cannot be penalised for the delay being occasioned. In any case the respondent company does not gain anything by delaying the project and is rather committed to deliver the project in the best standards of quality and performance. On the other hand, even the respondent company due to the uncontrollable delay in the delivery of the project is suffering because it has to pay the huge fees for renewal of licenses.
- 29. The respondent submitted that this honourable forum does not have the subject matter jurisdiction as the respondent



have not violated or contravene any of the provisions of the newly promulgated Act or the Rules made thereunder.

30. The respondent submitted that though the said project is going behind schedule of delivery, however the respondent have throughout conducted the business in a bona fide manner and the delay occasioned had been beyond the control of the respondent, the complainant has no cause of action to file the present complaint as the delay so occasioned is very much due to the factors so contemplated.

#### Determination of issues:

After considering the facts submitted by the complainant, reply by the respondent and perusal of record on file, the issues wise findings of the authority are as under:

31. With respect to the **issues** raised by the complainant, the authority came across that as per clause 3(a) of apartment buyer's agreement, the respondent has delayed in handing over the possession of the said apartment. The relevant clause regarding the possession of the said unit is reproduced below:

"3(a) offer of possession

...the Developer proposes to handover the possession of the said flat within a period of thirty-six (36) Months with grace period of 6 Months, from the date of commencement of construction upon receipt of all project related approvals including sanction of building plan/ revised plan and approvals of all concerned



authorities including the fire service department, civil aviation department, traffic department, pollution control department etc. as may be required for commencing, carrying on and completing the said complex subject to force majeure, restraints or restriction from any court/authorities...."

The consent to establish has been granted to the respondent on 02.12.2013. Accordingly, the due date of possession was 02.06.2017 and the possession has been delayed by 2 years 3 months and 9 days till the date of decision.

Thus, the respondent has failed in handing over the possession of the subject unit as per the terms and conditions of the apartment buyer's agreement and its obligation as envisaged under section 11(4)(a) of the Act ibid. As the promoter has failed to fulfil its obligation as per section 11 of the Act ibid, the promoter is liable under section 18(1) proviso read with rule 15 of the Rules ibid, to pay interest to the complainant, at the prescribed rate i.e. 10.35%, for every month of delay till the offer of possession.

#### Findings of the authority

32. The authority has complete jurisdiction to decide the complaint in regard to non-compliance of obligations by the promoter as held in *Simmi Sikka V/s M/s EMAAR MGF Land Ltd*. leaving aside compensation which is to be decided by the



- adjudicating officer, if pursued by the complainant at a later stage.
- 33. The complainant reserves her right to seek compensation from the promoter for which she shall make separate application to the adjudicating officer, if required. The complainant made a submission before the authority under section 34 (f) to ensure compliance/obligations cast upon the promoter as mentioned under section 11 of the said Act. The complainant requested that necessary directions be issued by the authority under section 37 of the Act ibid to the promoter to comply with the provisions and fulfil obligation.
- 34. Counsel for the respondent has brought certain material facts w.r.t pendency of the renewal of licence and he states that the delay is on the part of the concerned department. However, it was incumbent duty of the respondent/builder to get the licence renewed and keep every approval on record. No laxity can be granted to him on this pretext. As such, the complainant is entitled for delayed possession charges till the actual delivery of possession.
- 35. As per clause 3 (a) of the apartment buyer's agreement dated 23.5.2016 for unit no.144, 1st floor, tower-Orchid, in project



"Our Homes" Sector-37C, Gurugram, possession was to be handed over to the complainant within a period of 36 months from the date of commencement of construction after receipt of all approvals i.e. 02.12.2013 + 6 months grace period which comes out to be 02.06.2017. The respondent has failed to deliver the possession of the unit in time. As such, the complainant is entitled for delayed possession charges at prescribed rate of interest i.e. 10.35% per annum w.e.f 02.06.2017 as per the provisions of section 18 (1) of the Real Estate (Regulation & Development) Act, 2016 till the actual offer of possession.

# Decision and directions of the authority

- 36. After taking into consideration all the material facts as adduced and produced by both the parties, the authority exercising powers vested in it under section 37 of the Real Estate (Regulation and Development) Act, 2016 hereby issues the following directions to the respondent in the interest of justice and fair play:
  - i. The respondent is directed to pay the interest at the prescribed rate i.e. 10.35% per annum for every month of delay on the amount paid by the complainant from due



date of possession i.e. 02.06.2017 till the actual offer of possession.

- ii. The arrears of interest accrued so far shall be reimbursed to the complainant within 90 days from the date of this order and thereafter monthly payment of interest till offer of possession shall be paid before 10th of subsequent month.
- iii. Complainant is directed to pay outstanding dues, if any, after adjustment of interest awarded for the delayed period of possession.
- iv. The promoter shall not charge any amount/charges from the complainant which is not a part of the apartment buyer's agreement.
- v. Interest on the due payments from the complainant shall be charged at the prescribed rate of interest i.e. 10.35% by the promoter which is the same as is being granted to the complainant in case of delayed possession.
- 37. Complaint stands disposed of.
- 38. File be consigned to the registry.
