Proceedings-cum-order

The applicant/complainant vide application dated 23.04.2024 have requested for rectification of order dated 05.04.2024 in the above captioned complaint.

Application dated 23.04.2024 has been filed by the counsel of the complainant w.r.t. specific direction regarding addition of the name of the coallottee i.e., Mr. Vikas Narula in the builder buyer agreement which is to be executed by the respondent builder as per direction at para 40(b) of order dated 05.04.2024 passed by this authority.

It is a matter of fact that the abovementioned complaint was filed by two allottees namely Mr. Vikas Narula & Ms. Nitika Narula. Further the same complaint was admitted and the authority further observed that the name of Vikas Narula was not mentioned in the account statement dated 04.02.2020 issued by the respondent w.r.t. the subsequent unit admeasuring 750 sq. ft. instead the name of Nitika Narula was only written on it whereas the units admeasuring 500 sq. ft. each of both the allottees were amalgamated by the respondent it was also being mentioned by the counsel for the complainant during the course of hearing dated 05.01.2024.
