## Proceedings-cum-orders

The counsel for the respondent states that the application filed u/s 39 of the Act 2016 is not maintainable on two grounds:-

- i) The application has been filed after a period of 4 years of passing of the orders and the rectification can only be made within a period of 2 years under the provisions of Section 39 of the Act.
- ii) There is already an appeal No.141/2021 preferred before the Hon'ble Appellate Tribunal which was withdrawn by the appellant and the same was dismissed as withdrawn vide order dated 21.08.2023 and a review application has now been filed before the Hon'ble Appellate Tribunal which is pending adjudication. As per proviso to section 39 of the Act, no such amendment can be made in respect of any order in which an appeal has been preferred under the Act of 2016.
