## Proceedings-cum-order

The applicant-respondent has filed the present application on 28.02.2024 stating that the authority has through an oversight have missed the fact that the complainant had already taken the possession on 18.10.2019 of the unit to the complainant in the order dated 28.09.2021. The respondent has filed the present application seeking the rectification of directions (i) and (iii) in the order dated 28.09.2021 as the physical possession of the subject unit was handed over to the complainant on 18.10.2019 i.e., much before the said order and it was also stated under para 6 of written submissions filed by the respondent.

The counsel for the respondent-applicant states that the NCLT Delhi vide order dated 29.04.2024 in Company Petition No.445/2023 has imposed moratorium and IRP has been appointed and hence, the application for
