ORDER: (PARNEET S SACHDEV -CHAIRMAN)

1. Captioned Suo-motu complaint has been filed against the respondents to refund the pre-deposit amount of ₹1,91,231/- along with interest to

respondent no. 1, i.e., TDI Infrastructure Ltd., in terms of order dated 07.07.2023 passed by Hon'ble Appellate Tribunal in Appeal no. 508 of 2021. A notice dated 09.04.2024 issued to the respondent to present its case for disbursement of the amount as per orders of the Tribunal was successfully delivered on 12.04.2024.

2. On perusal of order dated 15.02.2023, passed by the Hon'ble Appellate Tribunal, it is clear that said amount of Rs 1,91,231/- along with interest accrued deserves to be returned/disbursed to the appellant, i.e., TDI Infrastructure Ltd. Relevant part of the said order dated 15.02.2023, is reproduced below for reference:

“The amount of Rs.1,91,231/- deposited by the applicant/appellant with this Tribunal, along with interest accrued thereon be sent to the learned Authority for disbursement to the applicant/appellant subject to tax liability, if any, as per law and rules.”

3. Therefore, present complaint is disposed with direction to the office to disburse the amount of Rs.1,91,231/- along with interest accrued to the respondent no. 1 in their bank account, details of which are as below:


