ORDER (Parneet S Sachdev-Chairman)

Registration No. HRERA-PKL-HSR-41-2018 dated 06.09.2018 was valid upto 31.12.2019. The respondent promoter has neither submitted an application for extension of registration nor completion certificate of the colony.

2. The matter was considered by the Authority on 07.08.2023 when the respondent promoter was directed to show cause as to why registration may not be revoked by the Authority U/s 7 of the RERA Act, 2016 and penalty proceedings U/s 61 read with Section 63 be not initiated for contravention of the provisions of the Act and not complying with the orders of the Authority.
3. When matter was considered by the Authority on 09.10.2023, the Authority had granted last opportunity to the respondent to comply with the orders failing which it will be constrained to impose penalty of ₹5 lac U/s 61 read with Section 63 of the provisions of the Act.
4. On 18.12.2023, Advocate Tarun Ranga appeared and submitted that the respondent forgot the Login Id and Password and sought time to file reply . The Authority directed that the Login Id and password be provided to the respondent and directed that the concerned E.O. should be personally present on the next date of hearing.
5. On 21.02.2024, J.E (HSVP) appeared and sought last opportunity to file reply. J.E (HSVP) submitted that E.O was on duty at the protest site of farmers agitation and therefore could not attend the hearing. The Authority informed that Login Id and password has already been provided to the promoter on 25.01.2024 on the registered email ID. The Authority asked the counsel to show the exemption letter of the E.O. for not attending the personal hearing. The J.E (HSVP) has also


not been authorised to attend the hearing. The Authority directed the counsel to submit Auction details of the last 4 years (after the lapse of registration of the project). If the same is not provided before the next date of hearing, it will be the personal liability of the concerned E.O. The Authority also directed the promoter to apply for extension of registration along with requisite fee.

The Authority imposed a personal cost of Rs.5000/- on the concerned E.O. for non-appearance in the hearing. The Authority also imposed penalty of ₹5 lac U/s 60,61 read with Section 63 of the provisions of the Act. The Promoter was directed to deposit the same in the registry of the Authority before the next date of hearing.

6. On 10.04.2024, learned counsel Sh. Tarun Ranga appeared and sought time to file reply as the orders of the Authority dated 21.02.2024 were uploaded on 09.04.2024. Acceding to the request of the learned counsel, the Authority granted time to the promoter to file reply before the next date of hearing. The Authority also directed that the concerned E.O. to be personally present on the next date of hearing.
7. Today, learned counsel Sh. Tarun Ranga appeared and informed that the extension application of the project will be submitted today. Sh. Rajesh Koth (E.O.) appearing via online mode requested the Authority to waive of the personal cost of Rs, 5000/- imposed on 21.02.2024. The Authority directs that a formal application should

be submitted in the Authority by the E.O. requesting to waiving of the cost. The Authority also directs that the penalty of Rs. 5 Lacs imposed on 21.02.2024 should be submitted in the registry of the Authority before the next date of hearing.
