<p>The present complaint was filed on 01.02.2019, the said complaint was listed on 30.09.2019 and held that <i>Nobody was present on behalf of the complainant despite repeated calls and waiting up to 03:45 P.M. A perusal of the case file shows that notice for this date was given to both the parties through Email but none has turned up. It shows that the complainant is not interest to proceed with the complaint. So, the same is ordered to be dismissed for want of prosecution.</i></p> <p>Thereafter, the complainant was file an application dated 05.02.2020, and requested for restoration of the said matter and the said application for restoration was rejected vide order dated 20.02.2020. The complainant has filed another application on 13.06.2024, for restoration of the said complaint with regard to the Hon'ble NCLT has come to an end and now the respondents are out of the insolvency proceeding but are liable to be tried before the Hon'ble court.</p> <p>The case was dismissed in default by the then Adjudicating Officer's order dated 30.09.2019 and later on an application for revival was also filed by the complainant-allottee which after examination was rejected by the Authority order dated 20.02.2020 and an email to this effect was also sent to the complainant allottee on 17.03.2020.</p>
