The aforesaid complaint was disposed off vide order dated 28.03.2023, of the Authority wherein the complainant was held entitled for interest at the prescribed rate of 10.70% for every month of delay from the due date i.e., 03.04.2013 till the receipt occupation certificate i.e., 18.07.2017 plus 2 months i.e., 18.09.2017. An application dated 08.05.2024 was filed by the complainant for rectification dated 28.03.2023.
