Proceedings-cum-order

The present complaint was filed by the complainant on 09.02.2021 and the reply was received on through e-mail only on 26.02.2021 and the said complaint was adjourned sine die by the authority vide order dated 06.04.2021 in view of order dated 04.03.2021 passed by NCLT declaring moratorium.

Thereafter, the complainant has moved an application dated 13.07.2023 for restoration of present complaint stating that vide order dated 24.05.2023, Ld. NCLT, Bench III, New Delhi has revived and restored the respondent company to its original position. In view of the above, the complainant is requesting that the present complaint is liable to be revived. The said application was allowed and the present application was allowed vide order dated 24.08.2023.

The counsel for the respondent has filed an application dated 26.12.2023 for dismissal of the complaint in view of the revival plan which is a settlement proposal between homebuyers, bank and the respondent. As per Chapter 14 of the said plan, the allottees of the project specifically agreed that they shall not pursue/initiate any and all legal proceedings against the respondent. It is further stated that no claim survives once the complainant herein has agreed to the said revival plan and moreover, the interest of the complainant herein has already been addressed in terms of the revival plan.
