<p>The complainant filed an application for restoration of the complaint. The said complaint was ordered 'Dismissed in Default' on 30.04.2024. The counsel for the complainant states that due to heavy work load and multiple court hearing in District Courts of Gurugram on 30.04.2024, he was unable to reach the Authority in time.</p> <p>On 23.01.2024, the complaint was dismissed in default due to the non-appearance of the complainant. Thereafter, the complainant filed an application for restoration. The matter was scheduled for 30.04.2024, but on that date, the complainant again did not appear, and the complaint was once more dismissed by default for non-appearance.</p> <p>The matter has already been dismissed in default twice.
