## Proceedings-cum-Order

The complainant filed an application for restoration of the complaint. The said complaint was ordered 'Dismissed in Default' on 30.04.2024. The counsel for the complainant states that due to heavy work load and multiple court hearing in District Courts of Gurugram on 30.04.2024, he was unable to reach the Authority in time.

On 23.1.2024, the complaint was dismissed in default due to the nonappearance of the complainant. Thereafter, the complainant filed an application for restoration. The matter was scheduled for 30.04.2024, but on that date, the complainant again did not appear, and the complaint was once more dismissed by default for non-appearance.

The authority observes that the matter has already been dismissed in default twice. The last order is reproduced as under:-

The counsel for the complainant alongwith his power of attorney filed an application dated 21.03.2024 for restoration of the complaint which was dismissed in default vide order dated 23.01.2024 due to non appearance of the complainant stating a reason that the previous advocate of the complainant could not attend the last date of hearing due to his bad health conditions.

In view of the above no case is made out for restoring the complaint. The application stands dismissed. File be consigned to the registry.
