**Proceedings *Cum ordine***

The aforesaid complaint was disposed of vide order dated 21.10.2022 due to settlement between the complainant and the respondent. As per the settlement deed dated 31.08.2022, the respondent had to pay amount of Rs.20,50,916/-. It is important to note that the complainant received an amount of Rs.6,15,275/- and the respondent has not paid the remaining 70% amount till date.

The Authority observes that clause 3 of Settlement agreement dated 31.08.2022 clearly mention that it has been agreed to pay Rs.20,50,916/- and the respondent has paid only Rs.6,15,275/- and has failed to pay the balance amount till date. The Authority has disposed the said complaint in terms of


