ORDER (ANIL KUMAR PANWAR-MEMBER)

- 1. This Authority through newspaper publication dated 17.08.2019 had invited objections against its proposal to confer rights on the Complainant-Association for completing the project and to sell un-allotted apartments by way of open auction for accumulating funds for completion of remaining development works. However, no objection has been received till date from any person including the respondent.
- 2. Learned Counsel for the respondent has informed the Authority that authorized representative of respondent company has delivered possession of the incomplete building to the complainant-association and had also signed an inventory of unused building material lying at the site. Said inventory was verified and counter signed by two representative of District Town & Country Planning, Faridabad. So, the complainant-association can now go ahead for completing the project.
- 3. Mr. N.K Jain, President of complainant-association has apprised the Authority about the following developments that had occurred since the last date of hearing:-
 - The number of members joining the complainant-association has increased to 118 and only 20 allottees have not yet joined the association.
 - ii. The number of unallotted flats in the incomplete project is six.

- iii. 114 members have already paid initial amounts demanded by the complainant-association and remaining members are yet to pay their respective amounts. The deficit amount required to be collected from each member would be around Rs. 2.15 lakh.
- iv. The Deputy Commissioner, Faridabad has not yet appointed his representative for carrying out auction of unsold units.
- v. The Association is in the process of obtaining electricity connection in coordination with the concerned department.
- vi. Agreements have been executed between the complainantassociation and its members.
- vii. The association is likely to complete the development and construction work within 10 months.
- 4. Keeping in view the above-mentioned circumstances, the Authority observes as under
 - a) The respondent shall disclose and furnish particulars of the unsold flats to the Authority with a copy to the complainant-association.
 - b) The complainant-association shall file monthly progress report with the Authority and also supply a copy thereof to the respondent company



- c) The Executive Director of this Authority shall send a letter to

 Deputy Commissioner, Faridabad for nominating his
 representatives in terms of the previous order of this Authority
 for auctioning the unsold apartments.
- d) The DTCP shall be requested to provide financial and other necessary help to the complainant-association to the extent as possible by taking all necessary steps including by taking action for invoking bank guarantee of respondent company.

5. The matter is adjourned to 13.11.2019.
