## **Proceedings-cum-orders**

The respondent has filed a maintainability application on 05.07.2023 stating that after offer of possession on 13.12.2021, the complainant approached the respondent on 24.12.2021 to address certain alleged grievances in respect to the due amount as per offer of possession.

The respondent offered a settlement offer to the complainant of Rs. 8, 50,000/- (including unbilled interest of Rs. 30,770 and special credit compensation of Rs. 8, 19,228.23).

In terms of the settlement, the complainant had to make the payment of the remaining payment of Rs.25,34,998/- instead of the outstanding due amount of Rs. 33,84,997/-in terms of the offer of possession dated 13.12.2021.

The respondent states that not only did the complainant accepted the said offer and executed a full and final settlement but has also acted upon it.

Further the complainant filed an application for withdrawal of complaint dated 29.05.2024 by stating that she wants to withdraw the present complaint due to personal reason.
