<b>Proceedings-cum-order</b>		
<p>The respondent had filed an application vide MA No. 104/2024 for rectification of order dated 13.12.2023, stating that the company has already invested the huge amount of cost while providing the electricity to the project and the same has been proportionally charged from the allottees and thus requested for allowing it to recover proportional electrification charges from the allottees. After considering the said application, the Authority observed that direction w.r.t recovery of electricity connection charges has already been granted to the respondent in para 30 of the order dated 13.12.2023. Accordingly, the rectification application dated 12.02.2024 was disposed off by the Authority vide order dated 20.03.2024.</p> <p>Thereafter, the respondent vide the present rectification application dated 26.06.2024, has brought to the notice of this Authority that an inadvertent error has occurred in the rectification order dated 20.03.2024 as the directions w.r.t the recovery of electricity connection charges are mentioned in para 29 of the order dated 13.12.2023, which has been inadvertently mentioned as para 30 in the rectification order dated 20.03.2024.</p> <p>Counsel for the complainant has no objection to the same.</p>


