<u>ORDER:</u>

RAJAN GUPTA, CHAIRMAN (ORAL):

Appellant remains unrepresented. Similar was the situation on the last two dates of hearing.

2. On 26.11.2024, when the case was taken up for hearing,

the following order was passed:

"Mr. Anand, learned counsel for respondent no. 2. submits that M/s Spaze Towers Private Limited is facing Insolvency Resolution Process (IRP) and Interim Resolution Professional (IRP) has been appointed. As per him, proceedings would henceforth continue before the competent Court. Thus, no lis survive in the instant appeal. Appellant, however, remains unrepresented.
