Proceedings

The respondent filed an application for rectification on 13.05.2024 regarding rectification in order dated 26.10.2023. The respondent through rectification application is seeking directions to modify order dated 21.12.2023 by clarifying the term "amount paid" as it does not include the amount paid by the complainant against the tax/cess etc. and no DPC amount to be paid against given two months to the complainant. Further, to provide a copy of judgment enabling to file an appeal against the order dated 21.12.2023. Further, the Authority has given two months' time at the cost of the applicant, even if the respondent is given two months' time to pay the amount demanded in terms agreed in BBA, the applicant should not be burdened with DPC obligations without any fault.

The counsel for the complainant states that respondent has filed an appeal bearing no. 618 of 2024 before the Hon'ble Appellate Tribunal hence the rectification application filed by the respondent in terms of section 39 is not maintainable. Also, the counsel for the complainant has apprised the Authority
