### <u>ORDER:</u>

### **RAJAN GUPTA, CHAIRMAN (ORAL):**

Mr. Vijay Partap Singh, Advocate put in appearance on behalf of the appellant and filed his Power of Attorney along with no objection from the counsel, who earlier represented the appellant-promoter. Same is taken on record.

2 At the outset, Mr. Gupta submits that he has already withdrawn proceedings initiated before the AO<sup>1</sup> at Gurugram. Same have been dismissed as withdrawn vide order dated 13.01.2025. He has produced a copy thereof, which is taken on record. Same reads as under:

Learned counsel for DH requests to withdraw execution petition. Request is allowed. In the facts mention above, execution petition is dismissed as withdrawn. File be consigned to record room."

Learned counsel for the appellant, on instructions from Mr. Vikas Dahiya-Authorised Representative of respondent No.2-Rakhi Dahiya, undertakes that he does not intend to file any other complaint either in the nature of complaint before the Authority or executing petition, with respect to cause of action espoused herein.

4. It appears that now no *lis*, thus, survives in this appeal.

5. In view of above, learned counsel for the appellant prays that he may be allowed to withdraw the instant appeal.

6. Prayer is accepted.

7. Appeal is dismissed as withdrawn.
